Application and dosage



1 | / 10 | water Work the liquid into a lather and clean with foam only.



Single-disk machine with shampooing brush: 600 - 1000 ml / 10 l water

Yarn pad method: 1 | / 10 | water

Spray cleaning solution onto the yarn pad and the floor. Clean with a single-disk machine with a yarn pad fitted. Vacuum after cleaning.



Carpet shampooing machine: 600 - 1000 ml / 10 l water

Note

Protect against frost. Test surface on an inconspicuous area for colour fastness before application. Only use cold water. Do not soak the textile coverings. Thoroughly exhaust after complete drying.

Raise pile. Changes or variations in colour of the product do not impact on the quality.
