## Application and dosage



Pre-treatment: Vacuum clean textile covering.

Depending on the level of dirt, leave a dilution of 100 - 500 ml / 10 l water to act for approximately 5-15 minutes. Water spray extraction.



Yarn pad method:

1 : 6 with water Spray cleaning solution onto the yarn pad and the floor. Clean with a single-disk machine with a yarn pad fitted. Vacuum after cleaning.

To remove water-soluble stains: 100 ml / 1 l water Dab dry with cloth.

#### Note

Protect against frost. Only use cold water. Do not soak the textile coverings. Test surface on an inconspicuous area for colour fastness before application. Thoroughly exhaust after complete drying. Raise pile. Changes or variations in colour of the product do not impact on the quality.
