Application and dosage



Daily routine cleaning: 100 - 200 ml / 10 I water



Intensive cleaning: 200 - 500 ml / 10 I water

Machine cleaning: 100 ml / 10 l water



Basic cleaning: 1000 ml / 10 l water



High-pressure cleaning: 1:5 to 1:10 with water

Note

Always use cold water.

Do not mix with other cleaning agents. When being used in the automat, the tanks should be regularly cleaned and rinsed. Changes or variations in colour of the product do not impact on the quality.
